2. On request, all riders must present a current negative Coggins and a health certificate issued within 45 days prior to the race.
3. All disputes, rules violations, and contest ambiguities will be settled in the chairman's sole discretion. The chairman's decision shall be final.

1. Assumption of Risk. 2. Indemnity and Release. THE UNDERSIGNED SHALL HOLD HARMLESS, DEFEND, PROTECT, AND INDEMNIFY THE TEXAS COWBOY REUNION AND ITS AFFILIATES, AGENTS, EMPLOYEES, SUCCESSORS, AND ASSIGNS (COLLECTIVELY THE "TCR") FROM ANY CLAIM, SUIT, LIABILITY, DEMAND, DAMAGES, OR COSTS (INCLUDING ATTORNEY'S FEES AND EXPENSES), ARISING FROM ANY ACT OR OMISSION ARISING FROM THE UNDERSIGNED'S PARTICIPATION IN THE TCR MATCHED HORSE RACES, INCLUDING CLAIMS BASED ON (A) INJURY TO OR DEATH OF ANY PERSON(S), INCLUDING THE UNDERSIGNED; (B) DAMAGE TO OR LOSS OF PROPERTY; OR (C) FAILURE OF THE UNDERSIGNED TO COMPLY WITH THE TCR COMPETITION RULES OR APPLICABLE LAW. THIS INDEMNITY AND RELEASE APPLIES TO ANY CLAIM BY THE UNDERSIGNED AS WELL AS CLAIMS BY ANY THIRD PARTY, AND SHALL APPLY EVEN IF ANY INCIDENT IS CAUSED IN WHOLE OR PART BY THE CONDITION OF THE TCR'S PROPERTY OR BY THE SOLE OR CONCURRENT NEGLIGENCE OF THE TCR.
